Community Supports Committee (CSC)

Description: To increase the number of adults with intellectual and developmental disabilities to love where they live by promoting and enhancing community-based supports and services.

Objective #1: Individuals with intellectual and developmental disabilities, family members, providers, case managers, and advocates will have increased access to information about legislation, policies, and services that impacts individuals with intellectual and developmental disabilities.

Key Activities:

1. For each year of the State Plan, co-sponsor the annual Day at the Capitol event on Oahu for individuals with intellectual and developmental disabilities and their families to participate in the legislative process by meeting with legislators about intellectual and developmental disabilities-related issues and concerns, legislative measures, attend public hearings, etc.,

- 2. For each year of the State Plan, co-sponsor the annual Maui Disability Alliance Legislative Forum on Maui in collaboration with the Maui Disability Alliance that consists of over 35 public and private agencies and organization.
- 3. For each year of the State Plan, co-sponsor the annual East Hawaii Disability Legislative Forum in East Hawaii in collaboration with the East Hawaii Developmental Disabilities Committee and public and private agencies and organizations on Hawaii Island.
- 4. For each year of the State Plan, co-sponsor the annual West Hawaii Disability Legislative Forum in West Hawaii in collaboration with the West Hawaii Developmental Disabilities Committee and public and private agencies and organizations on Hawaii Island.
- 5. For each year of the State Plan, co-sponsor the annual Kauai Legislative Forum in Kauai in collaboration with the Kauai Developmental Disabilities Committee and public and private agencies and organizations on Kauai.

Expected Outputs:

- 1. 550 people with IDD, families, service providers, other advocates, and policy makers participate in the annual Day at the Capitol event.
- 2. 225 people with IDD, families, service providers, other advocates, and policy makers participate in the annual Legislative Forum event on Maui.
- 3. 225 people with IDD, families, service providers, other advocates, and policy makers participate in the annual East Hawaii Disability Legislative Forum.
- 4. 125 people with IDD, families, service providers, other advocates, and policy makers participate in the annual West Hawaii Disability Legislative Forum.
- 5. 150 people with IDD, families, service providers, other advocates, and policy makers participate in the annual Kauai Disability Legislative Forum.

Expected Objective Outcomes:

- 550 people with IDD, families, service providers, other advocates attend the annual Day at the Capitol event and participate on the legislative process and meet with legislators and/or their staff to advocate for IDD-related measures
- 2. 225 people with IDD, families, service providers, other advocates and policy makers convey their issues and concerns and get information about IDD services at the annual Maui Disability Alliance Legislative Forum
- 3. 225 people with IDD, families, service providers, other advocates and policy makers convey their issues and concerns and get information about IDD services at the annual East Hawaii Disability Legislative Forum
- 125 people with IDD, families, service providers, other advocates and policy makers convey their issues and concerns and get information about IDD services at the annual West Hawaii Disability Legislative Forum
- 150 people with IDD, families, service providers, other advocates and policy makers convey their issues and concerns and get information about IDD services at the annual Kauai Legislative Forum

Objective #2: Advocate to increase transportation options on all islands in Hawaii.

Key Activities:

- 1. Convene meetings with County Council members in all Counties in Hawaii to explore new strategies for providing discounted bus fares for individuals with intellectual and developmental disabilities.
- 2. Collaborate with the Department of Health and State and Counties Department of Transportation to explore and identify strategies for promoting share rides, carpools, and use of a ferry system for individuals with intellectual and developmental disabilities.

Expected Outputs:

- 1. Two meetings will be held to explore strategies for providing discounted fares.
- 2. Four meetings will be held to explore strategies to promote share rides, carpools and the use of a ferry system.

Expected Objective Outcomes:

- 1. Individuals with IDD get discounted bus fares.
- 2. Transportation options include share rides and carpools.
- 3. Increased bus routes to accommodate individuals with IDD to catch public transportation.
- 4. Increase accessible buses to accommodate individuals with IDD to utilizes public transportation.

Data Evaluation and Measurement:

- 1. Sign-in sheets for meetings with County Council members.
- 2. State legislature or counties pass legislation to provide discounted bus fares for people with IDD.

Key Activities:

1. Initiate legislation and advocate for a \$25.00 a month increase for a total of \$75.00 a month for personal allowance.

Expected Outputs:

- 1. 50 Medicaid H&CBS Waiver providers will be educated on the legislation.
- 2. 50 Medicaid H&CBS Waiver providers will educate 1000 individuals with IDD on the proposed legislation.

Expected Objective Outcomes:

- 1. 50 Medicaid H&CBS Waiver providers will submit testimony to the legislators in support of the legislation.
- 2. 500 individuals with IDD will submit testimony to the legislators in support of the legislation.
