08.21.23 CMIST Snapshot

American Red Cross staff strive to complete CMIST framework interviews to comprehensively screen access and functional needs among shelter client households. Efforts to complete interviews are made on an ongoing basis and the American Red Cross continuously engages in activities and services to address identified needs. CMIST metrics are based on voluntary household client self-disclosures and households may disclose needs in multiple areas.
